By virtue of my power under section 13(b) of the Performers and Broadcasters Rights Law, 5744-1984² (hereinafter: the "Law") and with the consent of the Constitution Law and Justice Committee under section 48(a) of the Basic Law: The Government³ and section 2(b) of the Penal Law 5737-1977⁴, I hereby order as follows:

Definitions

1. In this Order –
"World Trade Organization" – the World Trade Organization constituted by the agreement signed in Marrakech on 15 April 1994;
"Foreign performance" – a performance made in a member state;
"Member state" – a state that is a member of the World Trade Organization;
"Phonogram" – as defined in the Copyright (Convention for the Protection of Producers of Phonograms) Order, 5738-1978⁵

Application of Provisions of the Law

2. The provisions of the Law set out below shall apply to a foreign performance:
 - (1) section 2 –
 - (a) paragraphs (1), (2)(a) and (4) in respect of the recording of a performance on a phonogram;
 - (b) the first part of paragraph (3) in respect of the real-time broadcast of a live performance only, not including a secondary broadcast;
 - (2) sections 1, 3, 4, 5 through 9, 10, 11 and 14 through 17.

Commencement

3. This Order shall commence on 23 Tevet 5760 (1 January 2000).
