The following communication, dated 8 October 2003, has been received from the Permanent Mission of the Philippines.

"With reference to documents G/SG/N/8/PHL/2/Suppl.1-G/SG/N/10/PHL/1-G/SG/N/11/PHL/1 dated 17 April 2002, concerning the notification of the safeguard measure imposed on imports of ceramic floor and wall tiles, the Permanent Mission of the Philippines notifies that the list of developing countries exempt from the safeguard measure that originally accompanied the notification should be replaced by the list below".
