In order to assist Members, the following are deadlines for submissions established by the Committees on Anti-Dumping Practices, Subsidies and Countervailing Measures, and Safeguards, and subsidiary bodies, at their meetings held on 25, 29, and 30 April 2002, respectively.

A. AD/CVD LEGISLATION NOTIFICATIONS

The Secretariat will circulate to Members in mid-September 2002 a list of the **new notifications of legislation** that will be on the agenda for review at the regular meetings in October 2002. Pursuant to procedures adopted by the Committees, notifications circulated in all three WTO working languages not later than 12 September 2002 will be reviewed at the Committees' October regular meetings. Although a definitive list cannot be provided until that date, the following notifications have already been received and are expected to be reviewed at that meeting:
