Revision

The Decision on the Treatment of Interest Charges in the Customs Value of Imported Goods adopted by the Committee (G/VAL/5) requires each Member to notify the Committee of the date from which it will apply the Decision. The Decision on the Valuation of Carrier Media Bearing Software for Data Processing Equipment adopted by the Committee (G/VAL/5) requires those Members adopting the practice referred to in paragraph 2 of the Decision to notify the Committee of the date of its application. This document updates the listing of document references containing the information received from Members in pursuance of these provisions (G/VAL/W/5, Rev.1, 2, 3, and Corr.1, and Rev.4 - 12). A reference for Indonesia, which is applying the Decision on Interest Charges, has been added to this document.
