

**International Dairy Agreement**

**DERESTRICTION OF INTERNATIONAL DAIRY AGREEMENT (IDA) DOCUMENTS**

**Decision Adopted by the International Dairy Council on 17 September 1996**

1. Considering the Decision adopted by the General Council on Procedures for the Circulation and Derestiction of WTO Documents of 18 July 1996 (WT/L/160/Rev.1), the International Dairy Council (IDC) *decides* to derestict the following documents as of 17 September 1996:

2. Furthermore, the IDC decides that as of 17 September 1996 all documents in the IDA/- series be circulated as unrestricted, except for working documents. Such documents shall be considered for derestriction six months after the date of their circulation.
3. Notwithstanding paragraph 2, a document shall be issued as restricted if, at the time a Party submits the document to the Secretariat, the Party so indicates to the Secretariat. Such documents shall be considered for derestriction six months after the date of their circulation.
